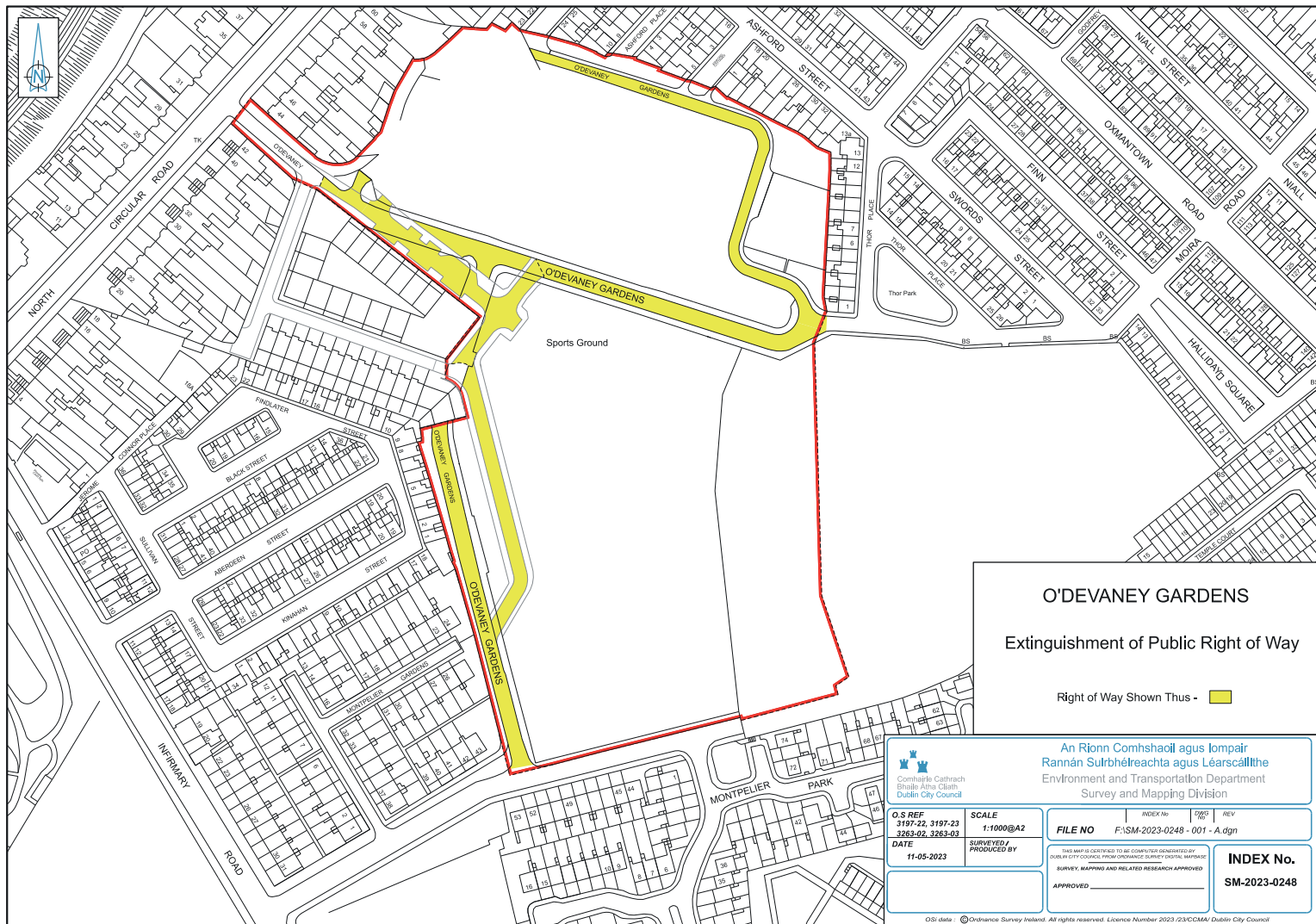

Tá an Ceart Slí Poiblí tagartha le taispeántar ag léarscáil agus is féidir é a scrúdú ag Oifig Ceantair na Cabraí Chomhairle Cathrach Bhaile Átha Cliath, 97 Bóthar Nua na Cabraí, Baile Átha Cliath 7 le linn na ngnáthuaireanta oscailte 10am – 1pm, Luan go hAoine ó Dé Céadaoin an 24 Bealtaine 2023 ar feadh tréimhse nach lú ná 1 mhí amháin. Beidh an líniocht ar fáil freisin ar mhól comhairliúcháin Chomhairle Cathrach Bhaile Átha Cliath ó **Dé Céadaoin an 24 Bealtaine 2023** agus glacfar le haigneachtaí sa mhól ó **Dé Céadaoin an 24 Bealtaine go dtí meán oíche Dé Déardaoin an 6 Iúil 2023**.

ROADS ACT 1993 – SECTION 73 NOTICE OF INTENTION TO EXTINGUISH THE PUBLIC RIGHT OF WAY

In accordance with Section 73(1) of the Roads Act 1993 Dublin City Council hereby gives notice that it is considering the proposal to Extinguish the Public Right of Way over lands known as Phase 2 development site, O'Devaney Gardens, Dublin 7. Due to the proposed development of the site it is necessary to extinguish these roads per the map provided above to facilitate the realignment of roads within the Phase 2 development.

The current right of way to be extinguished, as shown in yellow, can be seen on the attached map reference **SM-2023-0248**.

The referred Public Right of Way is indicated on a map, which may be inspected at the Cabra Area Office of Dublin City Council, 97 New Cabra Road, Dublin 7, during normal opening hours of 10am – 1pm, Monday to Friday, from Wednesday the 24th of May 2023 for a period of no less than 1 month. The drawing will also be available on the Dublin City Council consultation hub from **Wednesday the 24th of May 2023** and submissions will be accepted through the hub from **Wednesday the 24th of May until midnight on Thursday the 6th of July 2023**.

Any representations or objections, to this proposal, can also be made in writing to the Area Manager, Cabra Area Office, 97 New Cabra Road, Dublin 7 or by email to cabraoffice@dublincity.ie and received no later than 4pm on Thursday the 6th of July 2023.

It should be noted; that person making such written representations or objections may make a request to state their case, at an oral hearing, to that person that has been appointed by the Local Authority for that purpose.
