



## **CINNEADH AR AN IARRATAS TOILITHE FORBARTHA DON FHEIRM GHAOITHE AMACH ÓN gCÓSTA AWEL Y MÔR**

Ar an 24 Meán Fómhair 2021, fuair Éire fógra trasteorann ar Mheasúnacht Tionchair Timpeallachta (MTT) le haghaidh iarratais ar chead forbartha don Fheirm Ghaoithe bheartaithe Amach ón gCósta Awel y Môr. Rinne Údaráis Phleanála in Éirinn éascaíocht ar chomhairliúchán poiblí MTT trasteorann ar bhonn náisiúnta, mar a cuireadh ar fáil faoi théarmaí na Comhdhála ar Mheasúnacht Tionchair Timpeallachta de chuid Choimisiúin Eacnamaíoch na Náisiún Aontaithe d'Eoraip (CENAE) i gComhthéacs Trasteorann (An Chomhdháil Espoo).

Ar an 20 Meán Fómhair 2023, de réir Ailt 6(2) den Chomhdháil Espoo, chuir an Roinn Slándála Fuinnimh agus Neodrach in iúl don Aire Tithíochta, Rialtas Áitiúil agus Oidhreacht gur ghlac an Rúnaí Stáit cinneadh chun Ordú Toilithe Forbartha a bhronnadh ar an bhFeirm Ghaoithe Awel y Môr.

## **DECISION ON THE DEVELOPMENT CONSENT APPLICATION FOR THE AWEL Y MÔR OFFSHORE WIND FARM.**

On 24 September 2021, Ireland received a transboundary Environmental Impact Assessment (EIA) notification for an application for development consent for the proposed Awel y Môr Offshore Windfarm. Planning Authorities in Ireland subsequently facilitated a nationwide transboundary EIA public consultation, as provided for under the terms of the United Nations Economic Commission for Europe (UNECE) Convention on Environmental Impact Assessment in a Transboundary Context (the Espoo Convention).

On 20 of September 2023, in accordance with Article 6(2) of the Espoo Convention, the Department for Energy Security and Net Zero, notified the Minister for Housing, Local Government and Heritage of the decision taken by the Secretary of State, to grant a Development Consent Order for the Awel y Môr Offshore Windfarm.
