1.0 Introduction

This is the Strategic Environmental Assessment (SEA) Environmental Report for the proposed amendments to the planning scheme for the North Lotts/Grand Canal Dock (Docklands) Strategic Development Zone (SDZ). The purpose of this report is to provide a clear understanding of the likely environmental consequences of decisions regarding the amendment of the Planning Scheme. The SEA is carried out in order to comply with the provisions of the Planning and Development (Strategic Environmental Assessment) Regulations 2004 (SI No. 436 of 2004) as amended. This report should be read in conjunction with the Environmental Report of the adopted Planning Scheme.


1.2 Background

On 18th December 2012, the Government designated lands at North Lotts and Grand Canal Dock in Dublin's Docklands as a Strategic Development Zone (SDZ). This Order was made in accordance with Part IX of the Planning and Development Act 2000-2011, and Dublin City Council, as Development Agency (S.I.no. 530/2012) subsequently prepared a planning scheme for the lands.

Under S.I.no. 530/2012 the area is set out as an SDZ 'for the provision of residential development, employment services, commercial activities (including financial services and office, hotel, conference, leisure and retail facilities), cultural facilities, embassies, emergency services, childcare services, educational facilities, transport facilities and community facilities referred to in Part III of the First Schedule to the Act of 2000.'

The North Lotts and Grand Canal Dock SDZ Planning Scheme, in its chapter on movement (chapter 4), encourages pedestrian and cyclist movement through the area as part of its sustainable transport aims. Objectives set out in the chapter reflect this.




Figure 35 of the original Planning scheme.





Fig 35- Development Code for City Blocks

In relation to new bridges, the scheme illustrates two pedestrian bridges over the Liffey; a western bridge at Forbes Street, and one further east /downriver at Castleforbes Road. Please refer to orangecoloured dashed arrows on the map below (extract from Fig 35 of the SDZ scheme, page 178).



The Forbes St Bridge (westernmost route illustrated above) would accommodate a desire line from Spencer Dock Luas stop and Docklands Road Station to Grand Canal Square.

1.2.1 Proposed amendments to the Planning Scheme

The North Lotts and Grand Canal Dock SDZ Planning Scheme contains an objective to provide a pedestrian/cycle bridge across the River Liffey at Forbes Street. This is represented in figure 35 of the scheme (p178) by the dotted orange-coloured arrow on the left.

The proposed amendment now seeks to omit this, replacing it with a bridge at New Wapping Street/Blood Stoney Road.

For clarity, the new location is illustrated in the graphic below by a pink dashed arrow. Note that the bridge would be designed to open, to allow boats/vessels to pass through, and would be proximate to the new Central Bank Building on the North Quays.

Proposed Amendments to North Lotts and Grand Canal Dock Planning Scheme

Text Changes

Page 66. Section 4.4.4.1, start 2nd para, and “The ~~two~~ proposed pedestrian/cyclist bridges across the Liffey are crucial to improving”.... etc.

Page 127. Section 4.10 4.1.4; Omit final sentence in 2nd para, i.e. “ ~~A bridge link is also proposed ...Spencer Dock Square~~”.

P 127, third column, 3 lines down, delete text , ~~the creation of a new pedestrian bridge connection linking Spencer Dock with Grand Canal Square...~~

Page 191. Last sentence in second bullet point to be amended “Also provides links to new pedestrian bridge across to ~~Forbes Street~~ Blood Stoney Road”

Page 193. New bullet point to be added to be added to end of section 3 (public realm) as follows; **New pedestrian/cycle bridge across the River Liffey connecting New Wapping Street to Blood Stoney Road.**

The proposed amendments to the planning scheme have been assessed following this same criteria and set of environmental protection objectives. The Evaluation Matrix is set out in Appendix A. The proposed amendments did not alter the impact on the environmental receptor. The amendments proposed were deemed to have insignificant or no impact on the environmental receptors.

Strengthening Mitigation

It is considered that adequate mitigation measures have been included to offset any potential impacts on the environmental receptors.

Conclusion

In conclusion, it is apparent from the assessment of amendments proposed to the North Lotts and Grand Canal Dock planning scheme as set down in this Screening Report, that taking into account the measures that have already been integrated into the Plan which contribute towards environmental protection, environmental management and sustainable development, it is determined that all potential adverse effects arising from the proposed amendments are either present already (beneficial) and will be further contributed towards or will be mitigated so as not to be significant (adverse). It is not considered that these changes to the plan will impact on the environmental receptors given the range of mitigatory measures included in the planning scheme.
