1 PROJECT OVERVIEW

Dublin City Council with the support of the National Transport Authority proposes to implement interim measures to improve the walking and cycling facilities at Hanlon's Corner junction.

These are advance improvement works ahead of more extensive alterations to this junction which are expected in the coming years as part of the Blanchardstown to City Centre CBC Bus Connects project and the North Circular Road Walking & Cycling permanent scheme.



2 BENEFITS OF THE SCHEME

- Closing the left slip lane at the north west corner of the junction improves pedestrian movements across Old Cabra Road and reduces any conflict between cyclist travelling straight and left turning motorists
- Provide protected cycling facilities to cater for all ages and abilities

3 KEY FEATURES

The interim scheme will improve pedestrian facilities and provide a safer environment for cycling. The improvements include;

- Removal of the left turn slip lane from the North Circular Road (NCR) onto the Old Cabra Road. Left turning movements from NCR into Old Cabra Road will be retained
- Installation of a protected cycle lanes on both sides of the road along the NCR western arm and along parts of the NCR eastern arm
- Widening and protection of the cycle lane on Prussia Street approaching Hanlon's Corner and introduction of a short section of southbound protected cycle lane on Prussia Street approaching Park shopping centre
- Re-surfacing of the entire junction

4 MINOR TRAFFIC DISRUPTION DURING INSTALLATION

It is anticipated that the installation works on this scheme will commence early 2023. In order to deliver this scheme, there will be some minor temporary disruption to traffic to the area. Dublin City Council, in collaboration with our contractor will endeavour to minimise this as much as possible.
